2. NATURE OF WORK:

The works comprise the outcome of the preliminary studies carried out and the detailed informations provided in the technical specifications. (Document V)

3. LOTS:

The work is in single lot:

- 4. ESTIMATED COST: The estimated costs after preliminary studies is 12 500 000 franc Cfa
- 5. PARTICIPATION AND ORIGIN:

The tender is open to duly legalized Cameroonian enterprises that fulfill the requirements of this invitation to tender.

6. SITE VISIT:

It is important for all bidders to visit the site before tendering and to present a site visit report.

7. FINANCING:

The works which form the subject of this invitation to tender shall be financed by Public Investment Budget of the 2025 financial year; Budget Head No: 59 46 158 01 451905 523112.

10. Bid bond

Each bidder must include in his/her administrative documents a bid bond issued by a first rate bank approved by the Ministry in charge of Finance and recognized by COBAC (Commission Bançaire pour l'Afrique Centrale) featuring on the list in Document 11 of this tender file of an amount of 250 000 frs (Two hundred and fifty thousand) Franc Cfa.

<u>NB:</u> It is set at 2 % of the estimated amount, all taxes inclusive, and with a validity period of ninety (90) days from the date the bids are opened.

12. ADMISSIBILITY OF OFFERS:

Under penalty of rejection, the required administrative documents must be imperatively produced as original documents or photocopies certified as authentic by the issuing authority, in accordance with the Special Regulations of the Invitation to Tender. They must obligatorily not be older than three (3) months preceding the date of submission of bids.

Any bid not in compliance with the specifications of this tender notice and file shall be declared inadmissible. Notably, the absence of the bid bond issued by a first rate bank approved by the Ministry in charge of finance or its non-compliance with the model documents of the tender file shall lead to outright rejection of the bid without any possibility of appeal.

13. OPENING OF BIDS (Place, Date and Time):

The bids shall be opened in a single (01) phase on 25/03/2025 at 11:00am local time by the Fako Divisional Tenders Board in the office of the President, located at the Former Limbe I Council Building Down Beach Limbe. 14. DURATION OF EXECUTION:

The maximum period provided for the execution of the works is fixed at three (03) months.

15. EVALUATION CRITERIA

15.1: ELIMINATORY CRITERIA

Bids shall be rejected when:

- 3- There's any fake document, False declaration or forged document
- 4- There's absence of quantified unit price
