1. Subject of the invitation to tender:

Within the framework of the FEICOM low income councils funding, the *Lord Mayor of Limbe III Council* in favour of the ministry of basic education hereby launches an Open National Invitation to Tender for the Construction of TWO BLOCKS OF TWO (02) classrooms, equipped with desks and teachers table IN GOVERNMENT SCHOOLS MBOMO AND KANGE

2. NATURE OF WORK:

The works comprise the outcome of the preliminary studies carried out and the detailed information provided in the technical specifications. (*Document V*)

3. LOTS:

The work is not in lots;

4. ESTIMATED COST:

The estimated costs after preliminary study is fifty million (50,000,000) francs CFA

5. PARTICIPATION AND ORIGIN:

The tender is open to duly legalized Cameroonian enterprises that fulfill the requirements of this invitation to tender.

6. SITE VISIT:

It is important for all bidders to visit the site before tendering and to present a site visit report.

7. FINANCING:

The works which form the subject of this invitation to tender shall be financed by FEICOM'S FINANCIAL ASSISTANCE COMMITTEE FOR COUNCILS (CCFF-C) Code No. ARSW/008/2022

8. CONSULTATION OF THE TENDER FILE:

Interested eligible bidders may obtain further information during working hours as from the date of publication of this tender notice, at the *Limbe III Council*

9. ACQUISITION OF TENDER FILE:

The complete tender file may be obtained from the *Limbe III Council* (office of the Communal Development Officer's office) upon presentation of a treasury receipt attesting to the payment of a non-refundable sum of Fifty thousand (50,000) FCFA at the *Limbe III Municipal Treasury*. (7:30 AM TO 3:30PM)

10. Bid bond

Each bidder must include in his/her administrative documents a bid bond issued by a first rate bank approved by the Ministry in charge of finance and recognized by COBAC (Commission Bancaire pour l'Afrique Centrale) featuring on the list in Document 12-of this tender file of an amount of One million (1,000,000) Francs CFA.

***NB:** It is set at 2 % of the estimated amount, all taxes inclusive, and with a validity period of ninety (90) days from the date the bids are opened.*

11. SUBMISSION OF BIDS (Place, Date and Time):

Each bid drafted in English or French in *seven (07) copies including the original and six (06) copies* marked as such, should reach the **Limbe III Council** (office of the Communal Development Officer's office) on 12/11/2024 at 12.00PM local time and labeled.

***NOTE:** Any document poorly drawn-up, not bound as per Article 24 of the Public Contracts Code or not produced in Seven (7) copies shall be rejected.*

12. ADMISSIBILITY OF OFFERS:

Under penalty of rejection, the required administrative documents must be imperatively produced as original documents or photocopies certified as authentic by the issuing authority, in accordance with the Special Regulations of the Invitation to Tender. They must obligatorily not be older than three (3) months preceding the date of submission of bids.

Any bid not in compliance with the specifications of this tender notice and file shall be declared inadmissible. Notably, the absence of the bid bond issued by a first rate bank approved by the Ministry in charge of finance or its non-compliance with the model documents of the tender file shall lead to outright rejection of the bid without any possibility of appeal.

13. OPENING OF BIDS (Place, Date and Time):

The bids shall be opened in a single (01) phase on 14/11/2024 at 1:00PM local time by the LIMBE III COUNCIL Tenders Board at the Limbe III Council at Chop Farm - Bimbia. Only bidders may attend or their duly accredited representatives with Power of Attorney.

14. DURATION OF EXECUTION:

Four (04) months.

15. EVALUATION CRITERIA

15.1: ELIMINATORY CRITERIA

Bids shall be rejected when:

- 7- Incomplete administrative bid (bid bond)
- 8- Falsified or false declaration
- 9- Non-respect of models appended in the tender file
- 10- Absence of a bid bond
- 11- Bids submitted after deadline
- 12- Technical score less than 70%

16. AWARD CRITERIA

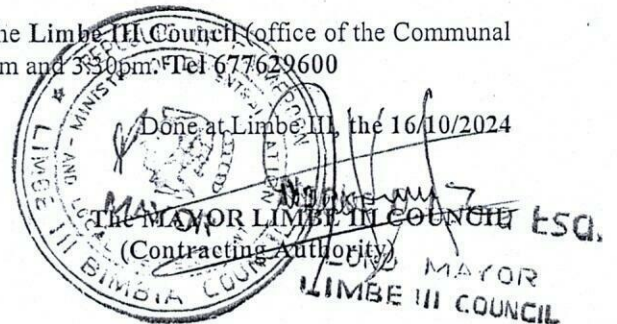
The Contract shall be awarded to the lowest bidder fulfilling the best technical and financial conditions.
