Services which form the subject of this invitation to tender shall be funded by the Public Investment Budget of the 2025 financial year.

### 7. Bid bond

Each bidder must include in his administrative documents, a bid bond issued by a first-rate banking establishment approved by the Ministry in charge of finance and whose list is found in document N° 12 of the Tender File, of an amount of THREE HUNDRED AND FIFTY THOUSAND Francs (350 000 F CFA) and valid for thirty (30) days beyond the date of validity.
