## 9. Bid bond

Each bidder must include in his administrative documents, a bid bond issued by a first-rate banking establishment approved by the Ministry in charge of finance and whose list is found in document No. 12 of the Tender File, of an amount of **200 000** and valid for thirty (30) days beyond the date of validity of bids

## 10. Admissibility of bids:

Under pain of rejection, the required administrative documents must be imperatively produced as original documents or photocopies certified as authentic by the issuing authority, in accordance with the Special Regulations of the Invitation to Tender, within the last three months, otherwise they shall not be accepted.

Any bid not in compliance with the specifications of this tender notice and tender file shall be declared inadmissible. Notably, the absence of the bid bond issued by a first rate bank approved by the Ministry in charge of finance or its non-compliance with the model documents of the tender file shall lead to outright rejection of the bid without any possibility of appeal.

### 11. OPENING OF BIDS:

The bids shall be opened in a single (01) phase on \_04\_/\_04\_/2025 at 11 am local time by the Tender Board of Tiko Council at the Tiko Council conference hall in the presence of the bidders or duly authorized representatives having full knowledge of the file. (Power of Attorney).

## 12. DELIVERY DEADLINE:

The maximum delivery deadline provided for by the Contracting Authority shall be two (02) months.

## 13. ELIMINATORY RITERIA:

Bid shall be rejected when:

In case of absence or non conformity of an administrative document, the bidder will be

given 48 hours to produce or replace the document in question. (Non conformity of administrative documents, technical offers and specifications, antecedents of bad execution of contracts etc

The technical score is less than the minimum required

# 14. MAIN QUALIFICATION CRITERIA:

The criteria relating to the qualification of candidates could indicatively be on the following:

- ❖ Access to credit or other financial sources 5,000,000 at least
- Supplier's references Yes / No
- Turn over 05 million at least.
- Antecedents of non-execution of contract or pending disputes Yes / No

The non-respect of 02 criteria shall cause the elimination of the bid.

**NB**: the marking scale for offers by award of points is banned in favour of the binary method (Yes or No).

## 15. VALIDITY OF BIDS:

Bidders shall be bound by their bids for a period of 90 (ninety) days with effect from the deadline set for the submission of bids.
