## TENDER NOTICE

### 1. SUBJECT OF THE INVITATION TO TENDER

Within the framework of the Public Investment Budget 2025, the Lord Mayor of ALOU Council, Contracting Authority hereby launches an **OPEN NATIONAL INVITATION TO TENDER BY EMERGENCY PROCEDURE FOR THE SUPPLY OF AGRICULTURE EQUIPMENTS TO CIGS ATELEFIEH, NDUNGATED, NJINAWUNG, M'MOUCK FARMERS, SAND PIT, NZEMBE FARMERS IN ALOU SUB DIVISION**

### 2. NATURE OF WORK

The work comprised **FOR THE SUPPLY OF AGRICULTURE EQUIPMENTS TO CIGS ATELEFIEH, NDUNGATED, NJINAWUNG, M'MOUCK FARMERS, SAND PIT, NZEMBE FARMERS IN ALOU SUB DIVISION** as per the detailed information provided in the technical specification and the quantitative estimates.

### 3. PARTICIPATION AND ORIGIN

The tender is open to duly legalized Cameroonian enterprises that fulfil the requirements of invitation to tender.

### 5. CONSULTATION OF TENDER FILE

The tender file can be consulted and obtained as from the date of publication of this invitation to tender, at **the ALOU Council Contracts Office**.

### 6. ACQUISITION OF TENDER FILE

With effect from the date of signature of this Tender Notice upon presentation of receipt attesting to the payment of a non-refundable fee of **thirty thousand (30,000) CFA francs**, payable at the Municipal Treasury ALOU. A copy of the receipt showing payment of the fee shall be attached to the bid.

### 7. SUBMISSION OF OFFERS

The bidder shall submit 01 original (indicated as such) and 06 copies of the bid in English or French at the Secretariat of the contract unit of the ALOU Council office against a receipt on or before **21/03/2025 at 10am**. The outer envelope shall bear the inscription:

**8. ADMISSIBILITY OF OFFERS**

Each bidder must include in his administrative documents, a bid bond issued by a first-rate banking establishment approved by the Ministry in charge of finance and whose list is found in document No. 12 of the tender file, of an amount of **Three hundred thousand (300 000) CFA francs** for a validity period for **Ninety (90) Days** from the date they opened.

On pain of being rejected, only originals or true copies certified by the issuing service or administrative authorities must imperatively be produced in accordance with the Special Regulations of the invitation to tender. They must obligatorily be not older than three (3) months preceding the date of submission of offers or may be established after the signature of the tender notice. Any offer not in conformity with the prescriptions of this notice and tender file shall be declared inadmissible. Especially the absence of a bid bond issued by a first-rate bank approved by the Minister in charge of Finance or the non-respect of the models of the tender file documents shall lead to a pure and simple rejection of the offer.

**9. OPENING OF BIDS**

The offers shall be opened in single phase. The opening of Administrative Offers (Envelope A), the Technical Offers (Envelope B) and Financial Offers (Envelope C) on **21/03/2025 at 11 am** local time by the ALOU Council Tenders Board situated at the ALOU Council Conference Hall.

**10. DELIVERY DEADLINE**

The maximum execution deadline provided for by the Contracting Authority shall be **One (01) Month**.

**11. Main eliminatory criteria**

Bid shall be rejected when:

- The lack of bid security;
- False declaration or forged documents
- Absences or non-conformity of administrative document after 48hours
- Technical Marks less than 70%
- Absence of a unit price

**12. Main qualification criteria**

The criteria relating to the qualification of bidders could indicatively be on the following:

- The non-respect of three (03) criteria shall cause the elimination of the offer.

**13. Contract award**

The contract shall be awarded to the bidder with the least financial offer having the technical and administrative files which are in conformity with the tender document/file.

**14. Validity of offers**

Bidders shall be bound by their bids for a period of Ninety (90) Days with effect from the date of opening of bid.

**15. Complementary information**
