#### 9. Admissibility of Bids

Bidders must include in their administrative documents, a bid bond issued by a bank approved by the Ministry in charge of Finance and recognized by COBAC featuring on the list in Document VII of the request for quotation of an amount of two hundred thousand (200.000) Francs CFA and valid for thirty (30) days beyond the validity of the bids. Under pain of being rejected, only originals or certified true copies from the issuing service or administrative authorities (Senior Divisional Officers, Divisional Officers, etc.) of the documents required must imperatively be produced in accordance with the special conditions of the request for quotation. They must not be older than three (03) months.

Any bid not in conformity with the prescriptions of this notice and request for quotation shall be declared inadmissible. Especially the absence of a bid bond issued by an approved bank by the Ministry in charge of Finance or the non-respect of the models of the orequest for quotation documents shall lead to outright rejection of the bid without appear

#### 10. Opening of Bids

A bid shall be rejected if:

- It has any fake or forged document;
- Absence of any quantified unit price.
- Noncompliance with the model bid documents.
- Abandoned or uncompleted contract
