2. Nature of works:

3. Execution time frame:

The maximum time frame provided for the execution of the works forming the subject of this Open National Invitation to Tender is **three** (03) **months per lot**, with effect from the date of notification of the service order to commence works.

7. Bid bond

Each bidder must include in his administrative documents, a bid bond issued by a first-rate banking establishment approved by the Ministry in charge of finance and whose list is found in document No. 11 of the Open National Invitation to Tender File, and of an amount of 2% which is valid for Ninety (90) days beyond the date of validity of bids being 600,000 CFA Francs for LOT 1 and 400,000 CFA Francs for LOT 2.

10. Acquisition of Open National Invitation to Tender file:

12. Admissibility of bids

Under penalty of being rejected, the administrative documents required, must be produced in originals or true copies certified by the issuing service or administrative authorities must imperatively be produced in accordance with the Special Regulations/conditions of the Open National Invitation to Tender.

They must not be older than three (03) months preceding the original date of submission of bids. Any bid not incompliance with the prescriptions of the Open National Invitation to Tender File shall be declared inadmissible. Especially the absence of a bid bond issued by a first-rate bank approved by the Ministry in charge of Finance.

13. Opening of bids:

The bids shall be opened in a single (01) phase on the **Friday 28 March 2025 at 11am** local time in the **Conference Hall**, at the Menji council office by **the competent Tender board**, in the presence of the bidders or duly authorized representatives having full knowledge of the file (power of attorney).

14. Evaluation criteria

i. Eliminatory criteria

Any bid not meeting with the requirements of the Open National Invitation to Tender File will be declared inadmissible. The eliminatory criteria are identified as follows:

Lack of bid bond or false bid bond;

❖ Forged or falsified documents in the Open National Invitation to Tender File;

Absence or non-conformity of an administrative document within 48hours after bids opening

❖ A technical score of less than 70%,

Omission of a quantified unit price in the financial offer;
