1 – PURPOSE:

Within the framework of the execution of the Public Investment Budget of 2025, the Mayor of Foubot council hereby launches an Open National Invitation to Tender for the construction of community store house of Njimbot2, West Region, Noun Division, Foubot council. Funding: BIP MINADER 2025.

2 – NATURE OF SERVICES

The works, which are the object of this open national invitation to tender shall consist the construction of community store house of Njimbot 2 (Marché des vivres) which includes:

- - Preparatory works;
- Earthworks;
- Foundation works;
- Elevation of blocks works;
- Roofing;
- Lumber and metallic works;
- Electricity works;
- Painting works;
- VRD;
- Miscellaneous.

3 – PARTICIPATION AND ORIGIN

Participation in this Invitation to tender shall be open to Cameroonian-based enterprises with experience in the domain.

4 – FUNDING AND PREVISIONNAL COST:

The works that are the subject of this invitation to tender shall be financed by the Public Investment budget MINADER 2025. Provisional cost – **Twenty three millions (23 000 000) FCFA.**

5 – CONSULTATION OF THE TENDER FILE:

The tender file may be consulted during working hours at Foubot council (Contracts Service), and ARMP upon publication of this invitation to tender.

6 – ACQUISITION OF THE TENDER FILE :

The tender file may be obtained from the Mayor of Bafoussam 1st subdivision council, located at Further information may be obtained during working hours from the Foubot

council upon submission of a treasury receipt attesting to the payment of a non-refundable sum of FCFA 50 000 (fifty thousand) to the municipal treasury of Foubot.

7 – SUBMISSION OF BIDS:

Each bid drafted in English or in French in **seven (07) copies** including one (1) original and six (06) copies shall be submitted to the Further information may be obtained during working hours from the Foubot council located at Foubot council not later than **at 11 a.m. local time** deposited against a receipt and shall be labelled:

8 – TENDER COMPLIANCE

Each bidder shall include in his/her administrative file, a provisional guarantee issued by a well-established bank, approved by the Ministry in charge of finance and whose list features in Document 12 of the Tender File with a validity period of 30 (thirty) days beyond the original date of validity of bids to the tune of: **Fourth hundred and sixty thousand (460 000) Francs CFA.**

Any other required administrative documents must be produced as original documents or photocopies certified as authentic by the issuing authority within the last three months or in course of validity, according to the listing provided for in the special regulations of the tender, otherwise they shall not be accepted.

Any bid not in compliance with the specifications of this tender notice and file shall be rejected. Notably, the absence of the provisional guarantee issued by a well-established bank approved by the Ministry in charge of Finance or its non-compliance with the model documents of the tender file shall lead to outright rejection of the bid.

9 – OPENING OF BID:

Bids shall be opened in one phase. The administrative, technical and financial bids shall be opened on **from 12 a.m local time** by the further information may be obtained during working hours from the Foubot council.

10 – EXECUTION DEADLINE:

The deadline of execution set by the Contracting Authority shall be three (03) months calendar day each.

11- MAIN ELIMINATORY CRITERIA :

- a) Administrative file, 48ours to complete
- b) Absence of the caution:
- c) Absence of tender compliance;
- d) False declaration, falsified or scanned documents;
- e) Be listed on the file of suspended enterprise;
- f) Finance capacity > or = 70%
- g) Omission of a quantified unit price in the financial offer;
- h) Certification of photocopies of certified documents.
- i) Absence of a sub detail of a quantified price.
- j) Absence of and honor declaration to have not abandoned a public contract during the last three years.

12- MAIN ESSENTIALS CRITERIA

The evaluation of technical bids will be made following the binary (yes / no) system based on the essential qualification criteria below:

- a) Financial capacity $\geq 70\%$ of provisional amount
- b) References of the company;
- c) Construction equipment to be mobilized;
- d) Senior staff of the company;
- e) Technical proposal;
- f) Presentation of the bid;
- g) Presence women in the members work

Only bidders having obtained **at least 70% of yes** shall be admitted to the financial analysis.

13. VALIDITY OF OFFERS

Bidders will remain committed to their offers for ninety (90) days from the deadline set for the submission of tenders.
