- Omission of a quantify unit price;
- Get a contract in the course of execution because of company.

- Financial situation (04 yes)
- References of the company (06 yes)
- Senior staff of the company (12 yes)



- Construction equipment to be mobilized (10 yes)
- Technical proposal (09 yes)
- General presentation of the bid (03 yes)
