12. Admissibility of offers.

Under pain of rejection, the administrative documents required, must be produced in originals or true copies certified by the issuing service or an administrative authority (Senior Divisional Officer, Divisional Officer...) in accordance with the Special Conditions of the invitation to tender.

13. OPENING OF BIDS

The bids shall be opened in *one* phase. The administration, technical and financial bids shall be opened on **8 AVR 2025** from 11 a.m. local time by Internal Commission of Public tender of Foubot Council.

Tender shall be opened in one go and in three steps:

- Step 1: Opening of envelope A containing administrative document (volume 1);
- Step 2: Opening of envelope B containing technical document (volume 2);
- Step 3: Opening of envelope C containing financial document (volume 3);

All tenderers may attend the opening session or each has themselves represented by one mandated person of their choice (even in the event of a joint-venture) with sound knowledge of their file.

14. EVALUATION CRITERIA

14.1. Eliminary criteria

Bids shall be eliminated according to the following criteria:

- To be under a termination consequence (article 18 (a,b,c) of the public contracts code);
- Failure of satisfying at least 70% of the criteria during the technical bid's evaluation;
- Non justification of at least one required reference;
- Omission of a quantified price unit in the financial offer;
- Incomplete Administrative document non-regulated in the 48 h after the opening;
- False declaration, forged or scanned documents;
- Certification of previously certified documents;
- Absence of the bid bond.

14.2. Essential criteria

The evaluation of technical bids based on the essential qualification criteria below:

- The presentation of the offer (04 yes)
- Supplier's references (06 yes)
- Experience of supervisory (12 yes)
- Material and essential equipment (11 yes)
- The execution methodology, the planning, the site's visit report and proposals of execution (09 yes)
- The financial offer of the candidate (05 yes)

15. AWARD

The contract will be awarded to the tenderer submitting the lowest bid and meets the necessary technical and administrative capacities.

16. VALIDITY OF OFFERS

Bidders will remain committed to their offers for thirty (120) days from the deadline set for the submission of tenders.
