The Mayor of the Commune of KOUOPTAMO, Project Owner, launches on behalf of the State of Cameroon, a National Open Call for Tenders for the completion of the above-mentioned works.

1. Purpose of the Call for Tenders:

As part of the campaign to rehabilitate municipal roads for the 2025/2026 financial year, the Mayor of the Municipality of KOUOPTAMO, Contracting Authority, is launching an open National Call for Tenders for the execution of maintenance work on certain sections of municipal roads:

3. Consistency of the works:

These works will consist of building and opening a road: such as

The overall period for execution of the works is 04 calendar months. This period runs from the date of notification of the service order to begin work.

7. Provisional security (bid guarantee):

Each bidder must attach to their administrative documents a receipt for deposit of the provisional security issued by the CDEC if it is subscribed in a first-rate bank. Said provisional security is a bid guarantee with a validity period of one hundred and twenty (120) days established according to the model indicated in the Call for Tenders Documents by a first-rate financial institution approved by the Minister in charge of Finance. The amount in FCFA of said guarantee is 1,900,000 (one million nine hundred thousand) CFA francs.

The provisional security will be released automatically no later than 30 days after the expiry of the validity of the offers for bidders who were not selected. In the event that the bidder is successful in the contract, the provisional security will be released after the constitution of the final security.

8. Consultation of the Call for Tenders File:

12. Admissibility of offers

Offers received after the date and time of submission of offers or those not respecting the method of separation of the financial offer from the administrative and technical offers will be inadmissible.

Under penalty of rejection, the required administrative documents must imperatively be produced in originals or in copies certified as true copies by the issuing department, in accordance with the provisions of the Special Regulations of the Call for Tenders.

They must be dated less than three (03) months from the initial date of submission of offers.

13. Opening of offers:

The opening of the bids will take place on 01/04/2025 at 09:00 sharp in the proceedings room of the Municipality of KOUOPTAMO.

The opening of the bids will take place in one time and in three stages:

- 1st stage: Opening of envelope A containing the administrative documents (volume 1),
- 2nd stage: Opening of envelope B containing the technical offers (volume 2)
- 3rd stage: Opening of envelope C containing the financial offers (volume 3)

All bidders may attend this opening session or be represented by a single duly authorized person (even in the case of a group) of their choice with perfect knowledge of the file.

14. Bid evaluation criteria:

Eliminary criteria

- Absence of an administrative document (submission deposit if taken out in an approved bank; (deposit receipt at the CDEC);
- Failure to comply with the submission template;
- Absence of a declaration of commitment to comply with environmental and social clauses
- Absence of a quantified unit price;
- Technical score lower than 70%;
- Absence or non-compliance of an administrative document other than the bond 48 hours after the opening of the bids;
- False declaration, falsified document.

Essential criteria:

The evaluation of technical offers will be made on the basis of the 26 essential criteria cited below:

- a) Presentation of the offer on 02 criteria;
- b) Personnel on 06 criteria;
- c) Material means on 08 criteria;
- d) Methodology on 05 criteria;
- e) Experience on 03 criteria.
- f) Categorization on 02 criteria
- 15. Validity period of offers:

Tenderers remain bound by their offer for ninety (90) days from the initial date set for the submission of offers.
