2. Nature of services:

Both administrative documents, technical and financial offers shall be do opened on 01/04/2025 at 10 AM by the internal Tenders Board of Kouoptamo council in the Conference hall. Each bidder may attend the opening session or may be represented by a person of his choice, heaving an expert and excellent knowledge of the offers

10. Tender evaluation criteria

11.1 Eliminary criteria

- a) Absence of an administrative document (submission deposit if taken out in an approved bank; (deposit receipt at the CDEC);
- b) Failure to comply with the submission template;

- c) Absence of a declaration of commitment to comply with environmental and social clauses
- d) Absence of Bid bond ;
- e) False declaration in the Tender file of the Bidder ;
- f) Omission of one quantified price in the BPU and DQE;
- g) Absence of the Administrative file after 48 hours
- h) Non satisfactory of 70% of Essential Criteria
- i) Non respect des conditions prevues au point 5 de l'AAO.

11.2. Essential Criterias :

- i) References of the Enterprise ;
- ii) Availability of materials and Essential Equipment ;
- iii) Experience of supervisory personnel;
- iv) Methodology and Planning of Execution.
- v) Attestation of categorization

11. AWARD OF CONTRACTS:
