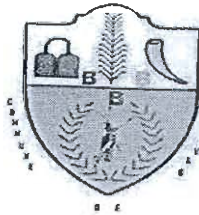

FINANCING: FEICOM / BAYANGAM COUNCIL

1. Subject of the invitation to tender:

As part of the improvement of the living conditions of the populations of the BAYANGAM Council, the BAYANGAM Mayor launches a National Open Bidding for the supply and installation of 24 "two in one" technology solar street lights with separate components in BAYANGAM.

2. Consistency of work

The project involves the supply and installation of 24 "two-in-one" solar streetlights, comprising a 320Wp/24V solar panel with a minimum life of 10 years, a 200Ah 24V lithium battery with a minimum life of 08 years, a 100w/24v/6800 lm LED luminaire, an IP66 MPPT solar regulator (charge controller) equipped with a twilight switch and a 20A to 24A dimmer, including class 5 flexible 1.5 mm² and 4 mm² connection cables. These lampposts, spaced 45 mm apart, will be supported by galvanized steel pylons 7 m high and 40 mm thick, with a base diameter of 20 cm and a top diameter of 8 cm, set on a reinforced concrete base measuring 80x80x100 cm, dosed at 350 kg/m³, with Q235 D30 steel anchoring rods, including panel fixing rails, cross-pieces and other fittings.

The work includes:

- site installation;
- execution studies;
- ordering solar equipment;
- picketing;
- the realization of reinforced concrete anchors;
- the supply of the components of the lampposts;
- assembly of street light components and training of personnel in charge of maintaining solar street lights;
- the installation of street lights;
- carrying out functional tests;
- various settings.

3. Execution time

The maximum period specified by the Employer for the execution of the work referred to in this Request for Proposals is **three (03) months** from the date of notification of the service order to start the services.



4. Allotment

The works are divided into a single lot.

5. Estimated cost

The estimated cost of this benefit is **thirty million (30,000,000) CFA francs, inclusive of tax.**

6.

Participation is open on equal terms to all eligible Cameroonian companies eligible and fulfilling the conditions set out in the Specific Tender Regulations (RPAO).

7. Financing:

The work, subject of this call for tender is financed by the budget of FEICOM and the Bayangam Council, financial year 2025 and following.

8. Tender mode

The submission method chosen for this consultation is **offline.**

9. Provisional surety

Under penalty of rejection, each tenderer must attach to his administrative documents a bid bond drawn up exclusively by a bank of first order approved by the Ministry in charge of Finance and listed in Exhibit 12 of the call for tenders document for an amount equal **six hundred thousand (600,000) CFA francs**, valid for a period of **thirty (30) days**, beyond the closing date for the validity of the bids.

10. Consultation of the Bidding Documents:

The tender documents can be consulted during working hours at BAYANGAM Town Hall, as from the publication of this notice.

11. Acquisition of the Bidding Documents:

The Tender Package may be obtained during working hours in the internal structure of the Commune of Bayangam for the administrative management of public contracts, upon publication of this notice, against payment of one Non-refundable sum of **forty thousand (40,000) CFA francs** payable to the Municipal Revenue of the Municipality of BAYANGAM COUNCIL or to the public treasure.

12. Submission of tenders

Bids written in english or french in seven (07) copies of which one (01) original and six (06) copies marked as such will be deposited under seal with a receipt at BAYANGAM Town hall, no later than 02 MAY 2025 to 10 local time at BAYANGAM Town hall.

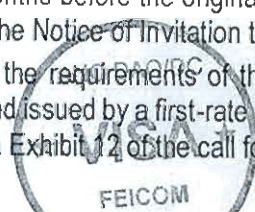
Tenders received after the deadline for submission of tenders will not be received.

13. Admissibility of tenders

In the event of rejection, the administrative documents required must be produced in original or certified copies by the issuing department or a competent authority (Senior Divisional Officer or Divisional Officer...), in accordance with the provisions of the Special Regulations of the Appeal d'offers.

They must be dated less than three (03) months before the original date for submission of tenders or have been established after the date of signature of the Notice of Invitation to Tender.

Any incomplete tender in accordance with the requirements of the Bidding Document shall be declared inadmissible. Notably the absence of the bid bond issued by a first-rate bank or an insurance company approved by the changed Ministry of Finance and listed in Exhibit 12 of the call for tenders document.



14. Opening of folds

The opening of the folds will be done in one time. The opening of administrative documents, technical and financial offers will take place from 24/11/2025 to 11, local time by the Internal Tender Boards, in the meeting room at BAYANGAM Town Hall.

Only tenderers may attend this opening session or be represented by a duly mandated person of their choice.

15. Evaluation Criteria

a. Elimination Criteria

The elimination criteria set out the minimum conditions to be admitted for evaluation according to the essential tanks. Failure to comply with these criteria will result in the tenderer's bid being rejected.

These include:

1. Absence of an administrative document not regularized within 48 hours;
2. **Absence of the bid bond at the opening of the bids;**
3. False declaration or falsified document;
4. Omission in the financial offer of a quantified unit price;
5. Technical score less than 80% ;
6. Be on the list of companies suspended by MINMAP (ART 92 OF THE CMP);
7. Having been terminated for default during the execution of a project financed by FEICOM (see Exhibit 13);
8. Absence of a certificate of non-abandonment of a work site on honor.

b. Essential Criteria

The criteria for the qualification of candidates will be indicative of:

- Financial capacity less than 16 100 000 CFA F;
- The references of the company in similar achievements;
- The execution time;
- Qualification and experience of staff;
- Material and logistical means compatible with the work to be carried out;
- General presentation of the offer;
- Financial offer.

The bid submitted by the bidder will include proof of acceptance of the conditions of the contract in the RPAO, in particular the Book of Particular Technical Clauses (CCTP).

Any bid that does not obtain a cumulative percentage of 80% « yes » will not have its financial offer examined

16. Assignment

The Contracting Authority shall award the Contract to the Bidder fulfilling the conditions set out in points 34.1 and 34.2 of the Supplementary Regulations.

17. Duration of Validity of Bids

Tenderers shall remain bound by their tenders for ninety (90) days from the closing date for the submission of tenders.

18. Right to modify quantities on award of contract

The Employer reserves the right to increase or decrease the quantity of certain tasks or services initially specified in the Bill of Quantities, without any change in unit prices or other terms and conditions, at the time of contract award, and prior to the signing of the contract by the successful bidder proposed by the Internal Contracting Commission. The cumulative amount of such changes should not exceed 20% of the proposed amount inclusive of VAT.

19. Addings

The Mayor of BAYANGAM COUNCIL serves right in case of necessity to add quit other useful subsequent modification to the present invitation to tender.
