1. Subject of the invitation to tender

As part of the implementation of the Public Investment Budget, the Mayor of Koutaba council, project owner launches on behalf of the Ministry of Public Health, Open National Tender work FOR THE CONSTRUCTION OF A HOSPITALIZATION PAVILLON AT THE KOUPA KAGNAM'S DISTRICT MEDICAL CENTER IN KOUTABA CONCIL, DEPARTMENT OF NOUN, WESTERN REGION.

2. Nature of works

The work, objects of this Open National Tender work for the construction of a hospitalization pavillon at the KOUPA KAGNAM'S District Medical Center KOUTABA Council, Noun Division, West Region. The consistency of these works is detailed in the "Detailed estimate" and in the "Unit Price List" of each lot.

3. Tranches/Allotment

The work is in a single batch.

The estimated cost of the operation following preliminary studies is 50,000,000 (five million) FCFA.

5. Estimated execution deadline

The maximum period provided by the Project Owner or the Delegated Project Owner for the completion of the work, the subject of this call for tenders, is four (04) calendar months. This period runs from the date of notification of the service order to begin the services.

6. Participation and origin

Participation in this call for tenders is open on equal terms to all construction companies under Cameroonian

7. Funding

The works subject to this call for tenders are financed by the Ministry of Public Health for the 2025 financial year on budget allocation line no.....

8. Bidding method

The submission method chosen for this consultation is: offline.

However, when both possibilities are open, a hidder cannot use both online and offline mode. However, when both options are open, a hidder cannot use both online and offline methods.

Each bidder must include in his administrative documents, a hand-endorsed bid bond, issued by a financial body or institution approved by the Minister in charge of finance to issue bonds for public contracts and whose list appears in document 14 of the Tender File (TF), the amount of which amounts to 1,000,000 (one million) CFA Francs and valid up to thirty (30) days beyond the initial date limit of the validity of bids. The absence of the bid bond issued by a first-rate bank or financial body of first category authorised by the Minister in charge of Finance to issue bonds for public contracts shall lead to the immediate rejection of the offer. A bid bond submitted but that does not have any relation with the consultation concerned shall be considered as absent. The bid bond presented by a tenderer at the bid opening session shall not be accepted.

10. Consultation of Tender File

12, Submission of bids

Each bid shall be drafted in English or French

-For offline submission, the offer in seven (07) copies including one (01) original and six (06) copies marked as such, must reach the receiver of Koutaba Town Hall no later than 24/04/2025 at 10 a.m. sharp and must bear the words:

13. Admissibility of bids

The administrative documents, the technical offer and the financial offer must be placed in separate envelopes and submitted in a sealed envelope.

The Project Owner shall not accept:

Bids bearing information on the identity of the tenderers:

Bids submitted after the closing date and time for submission of hids:

Envelopes without indication on the identity of the Invitation to Tender;

Bids non-compliant with the hidding mode;

Failure to comply with the number of copies specified in the RPAO or offer in copies only;

Any incomplete offer in accordance with the prescriptions of the Tender File shall be declared inadmissible. Especially the absence of a bid bond issued by a financial body or institution approved by the Minister in charge of Finance to issue bonds for public contracts or the failure to comply with the model documents of the Tender File shall lead automatically to the rejection of the bid without any other procedure. A bid bond submitted but not relating to consultation concerned shall be considered as absent. A hid bond presented by a bidder during the bid opening session shall not be accepted.

14. Opening of bids

The opening of the bids is done in one time and will take place from 11 a.m. sharp in the proceedings room of the Municipality of KOUTABA by the Procurement Commission of the Project Owner or the Delegated Project Owner in the procurement room, acts located in the Municipality of KOUTABA.

Only tenderers may attend this opening session or he represented by a person of their choice, duly authorised, even in case of a group of companies.

Under pain of being rejected, the required administrative documents must be submitted in originals or copies certified by the issuing service or the relevant administrative authority, in accordance with the provisions of

the Special Regulations of the invitation to tender. They shall be no later than 3 (three) months old from the original deadline for the submission of tenders or must have been issued after the date of signature of the Tender Notice.

In case of absence or non-conformity of a document in the administrative file during the opening of bids, after a 48(forty-eight) hours deadline granted by the Board, the file shall be rejected. [The opening of bids must take place no later than one hour after the deadline for receipt of tenders set out in the Tender File].

15. Evaluation criteria

The eliminatory criteria set the minimum conditions to be fulfilled in order to be admitted to evaluation following the essential criteria. They should not be the subject of notation. The failure to comply with these criteria shall lead to the rejection of the bidder's offer.

The eliminatory criteria include:

- Absence of hid bond at the opening of bids;
- Administrative file (no compliance of an administrative file) not completed in 48 h.
- False declarations, fraudulent schemes or forged documents:
- Appear on the updated list of suspended companies;
- Failure to comply with 70% essential criteria to the qualification threshold of technical bids:
- Absence of the sworn statement for not having abandoned contracts during the last three
- Failure to comply with bids file format;
- Absence of a quantified unit price in the financial offer;
- Omission of declaration to submit;
- Insufficient Production of the offer's copies;
- To have presented one civil servant;
- Absence of grading(categorisation) certificate;
- Absence of integrity charter dated and signed
- Absence of the dated and signed commitment statement to comply with environmental and social clauses.

NB: Depending on the specificity of the service, other relevant criteria may be added when drafting the Tender File

15.2 Essential criteria

Bids shall be evaluating according to the following criteria:

- The presentation of the offer (02 criteria);
- Supplier's references (06 criteria):
- Experience of supervisory staff (06 criteria);
- Material and essential equipment (06 criteria);
- The execution methodology, the planning, the site's visit report and proposals of execution (05 criteria);
- The financial offer of the candidate (04 criteria);

16. Award of contract

The Project Owner shall award the contract to the bidder whose bid meets the required technical and financial qualification criteria and whose offer was evaluated as the lowest by including as the case may be, the rebates proposed

17. Maximum number of lots:

This consultation constitutes a single lot.

Bidders shall remain committed to their bids for 90 days from the initial deadline set for the submission of bids.
