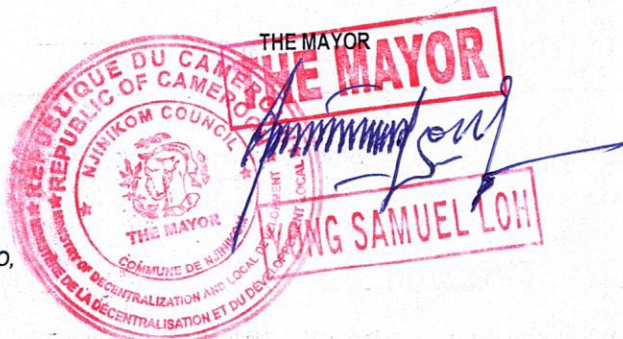
Article 03: Bidders who were not successful are requested to withdraw their files in two weeks. After this deadline, they shall be discarded;
