Bids received after the date and time deposit limits will not be accepted. Any bid not meeting the requirements of the tender file will be declared inadmissible.

11. BID BOND

Each bidder shall enclose with its administrative file, a bid bond issued by a first rank bank recognized by the Ministry of Finance to the tune of:

12. ADMISSIBILITY OF BIDS

To avoid facing rejection, the other required administrative documents must be produced in original copies or copies certified true by the issuing authority or the competent administrative authority (SDO, DO,...) in conformity with the regulations governing the Invitation to tender.

They must not be older than three (3) months preceding the original date of submission of bids or must not have been established after the signing of the tender notice.

Any bid that shall not comply with the prescriptions of this Tender Notice shall be declared inadmissible. Particularly, the lack of bid bond issued by a first rank bank, or non-respect of the model documents of the Tender File, shall lead to outright rejection of the bid.

13.OPENING OF BIDS

The opening of bids will take place in one (01) phase. The opening of administrative documents and both technical and financial offers shall take place the 02/06/2025 at 13:00 **prompt**, local time, by the Internal Tender Board Committee.

Only the bidders or their duly authorized representative, who has full knowledge of the bid, may attend the tender opening session.

14.EVALUATION CRITERIA

14.1 ELIMINATORY CRITERIA

The main eliminatory criteria are identified as follows:

- Misrepresentation ;
- Incomplete technical and / or financial bid ;
- Non compliance with a Tender file's model;
- Technical specifications of the vehicle different from specifications required;
- Technical note less than **8/9 "YES"**;
- Absence of Bid bond.

14.2 MAIN QUALIFICATIONS CRITERIA

The technical offers will be evaluated according to the binary notation system (YES/NO). Criteria relating to the qualification of bidders shall include the following aspects:
