**1. Subject of the invitation to tender:**

Within the framework of the Presidential Plan for the Reconstruction of the North West and South West Region, *The Mayor of Menji Council* hereby launches an **OPEN NATIONAL INVITATION TO TENDER (BY EMERGENCY PROCEDURE)**; Project Owners: **FOR THE REHABILITATION OF 36M BRIDGE OVER RIVER BETSUE LINKING MBETTA AND NJOAGWI IN IN MENJI MUNICIPALITY, FONTEM SUB - DIVISION, LEBIALEM DIVISION, SOUTH WEST REGION FOR 2025**

**2. Nature of works:**

The works comprise notably:

- **Installations;**
  - Site installation;
  - Provision for Security;
- **General Preliminary works / earthworks;**
  - Clearing of vegetation;
  - Tree felling;
  - Access (way in) fill;
  - Grading and compaction of access road;
- **Foundation – Embankment – Piles – Beams – Deck - Wingwall**
  - Excavation and opening of river bed;
  - Backfilling;
  - Demolition of concrete structures;
  - Reinforced concrete of dosage 350kg/m3;
  - formworks;
- **Signalisation and Security**
  - Guard rail
  - Metallic sign board;
  - Wooden Beacon;
- **Painting**
  - Anti-corrosive paint;
  - Oil paint;
  - Bituminous paint;
- **Traffic**
  - Deviation and traffic maintenance.

**3. Execution time frame:**

The maximum time frame provided for the execution of the works forming the subject of this invitation to tender is **three (03) months**, with effect from the date of notification of the service order to commence works.

**4. Lots:**

The works is in one lot.

**5. Estimated cost:**

The estimated budget inclusive of taxes is **forty million (40,000,000) FCFA**.

**6. Participation and origin:**

The tender is open to duly legalized Cameroonian enterprises that fulfil the requirements of this invitation to tender.

**7. Financing:**

Works of this invitation to tender shall be financed Presidential Plan for the Reconstruction and Development of the North West and South West Region (PPRD) of the 2025 financial year, Paragraph 59 B1 976 02 650001 523511



**8. Bid bond**

Each bidder must include in his administrative documents, a bid bond issued by a first-rate banking establishment approved by the Ministry in charge of finance and whose list is found in document No. 12 of the Tender File, and of an amount of **Eight Hundred Thousand (800 000) FCFA** which is valid for Ninety (90) days beyond the date of validity of bids.

**9. Consultation of tender file:**

The file may be consulted during working hours at the Menji Council - General Secretariat, Tel: 675007166 as soon as this notice is published.

**10. Acquisition of tender file:**

The file may be obtained from the Menji Council Office (General Secretariat) as soon as this notice is published against payment of the sum of **One hundred thousand (100,000) CFA francs**, payable at the Menji Municipal Treasury.

**11. Submission of bids:**

Each bid drafted in English or French in seven (7) copies including the original and six (6) copies marked as such, should reach the Menji Council Office (General Secretariat) not later than **Friday, 20 June 2025** at 10 am local time and should carry the inscription:

**12. Admissibility of bids**

Under penalty of being rejected, the administrative documents required, must be produced in originals or true copies certified by the issuing service or administrative authorities must imperatively be produced in accordance with the Special Regulations/conditions of the invitation to tender.

They must not be older than three (03) months preceding the original date of submission of bids or must not have been established after the signing of the tender notice.

Any bid not in compliance with the prescriptions of the Tender File shall be declared inadmissible. Especially the absence of a bid bond issued by a first-rate bank approved by the Ministry in charge of Finance.

**13. Opening of bids:**

The bids shall be opened in a single (01) phase on **Friday 20 June 2025 at 11am** local time in the **Conference Hall**, at the Menji council office by **the competent Tender board**, in the presence of the bidders or duly authorized representatives having full knowledge of the file (power of attorney).

**14. Evaluation criteria**

**i. Eliminary criteria**

Any bid not meeting with the requirements of the Tender File will be declared inadmissible. The eliminary criteria are identified as follows:

- ❖ Forged documents in the Tender Files;
- ❖ History of bad execution of similar work or on-going legal suit with Government;
- ❖ Lack of bid bond or false bid bond;
- ❖ Absence of attestation of site visit signed by honour by the bidder;
- ❖ Non respect of models of Tender file;
- ❖ A technical score of less than 70%;
- ❖ Non-respect of 3 essential criteria;
- ❖ Suspension by MINMAP
- ❖ Omission of a quantified unit price in the financial offer;
- ❖ Failure to in 48hrs make available a lacking administrative document





ii. **Essential criteria**

The main qualification criteria shall concern:

- General Presentation, compliance with the model bid.	Yes / No

15. **Award:**

The contract shall be awarded to the bidder whose bid will be judged essentially in compliance with the Tender File and who has the required technical and financial capacities to execute the contract satisfactorily and whose financial offer was evaluated as the **lowest** by including, where necessary, proposed rebates.

16. **Validity of bids**

Bidders will remain committed to their bids for *90 days* from the deadline set for the submission of bids.
