#### 1. Subject of the invitation to tender:

Within the framework of the execution of the PPRD Budget, the Mayor of Muyuka Council hereby launches an Open National Invitation to Tender by Emergency Procedure, FOR THE REHABILITATION OF THE MALENDE INTEGRATED HEALTH CENTER

#### 2. NATURE OF WORK:

The works comprise the outcome of the preliminary studies carried out and the detailed information provided in the technical specifications. (Document V)

- 3. NUMBER OF LOTS: The works which form the Subject of this invitation to tender are grouped in one lot.
- 4. ESTIMATED COST: The estimated costs after preliminary studies stands at Seventy Million (70,000,000) FCFA.

#### 5. PARTICIPATION AND ORIGIN:

Participation is open to all duly registered Cameroonian enterprises with the necessary technical, financial and legal capacities and who are not under suspension by the authority in charge of Public Contracts.

#### 6. SITE VISIT:

It is important for all bidders to visit the site before tendering and to present a site visit report.

#### 7. FINANCING:

The works which formed the subject of this invitation to tender shall be financed by PPRD Budget of the 2025.

#### 8. CONSULTATION OF THE TENDER FILE:

Interested eligible bidders may obtain further information during working hours as from 7:30 Am -3:30pm at the Technical Service in Muyuka Council

#### 9. ACQUISITION OF TENDER FILE:

The complete tender file may be obtained from the *Muyuka Council* upon presentation of a treasury receipt attesting to the payment of a nonrefundable sum of: **One hundred thousand** (100,000) FCFA at the *Muyuka Municipal Treasury*. (7:30am to 3:30pm).

#### 10. Bid bond

Each bidder must include in his/her administrative documents a bid bond issued by a first-rate bank approved by the Ministry in charge of Finance and recognized by COBAC (Commission Bançaire pour l'Afrique Centrale) or Insurance company featuring on the list in Document 11 of this tender file of an amount of **One million four hundred thousand** (1,400,000) FCFA.

<u>NB:</u> It is set at 2 % of the estimated amount, all taxes inclusive, and with a validity period of ninety (90) days from the date the bids are opened.

#### 11. SUBMISSION OF BIDS (Venue, Date and Time):

Each bid drafted in English or French in seven (07) copies including one original and Six (06) copies marked as such, should reach the technical service of Muyuka Council on or before 02/07/2025 at 8:00am local time and labeled.

#### 12. ADMISSIBILITY OF OFFERS:

Under penalty of rejection, the required administrative documents must be imperatively produced as original documents or photocopies certified as authentic by the issuing authority, in accordance with the Special Regulations of the Invitation to Tender. They must obligatorily not be older than three (3) months preceding the date of submission of bids.

Any bid not in compliance with the specifications of this tender notice and file shall be declared inadmissible. Notably, the absence of the bid bond issued by a first-rate bank approved by the Ministry in charge of Finance or its non-compliance with the model documents of the tender file shall lead to outright rejection of the bid without any possibility of appeal.

#### 13. OPENING OF BIDS (Place, Date and Time):

The bids shall be opened in a single (01) phase on 02/07/2025 at 09:00am local time by the Muyuka Council Internal Tender Board at the conference hall of the Muyuka Council building. Only bidders may attend or their duly accredited representatives with Power of Attorney.

14. **DURATION OF EXECUTION:** The maximum duration of execution provided by the Contracting Authority is three (03) months. The duration is from the date of notification of the Service Order to Start work

#### 15. EVALUATION CRITERIA

#### 15.1: ELIMINATORY CRITERIA

Bids shall be rejected when:

- ✓ There's absence of Bid Bond in the administrative documents
- ✓ Failure to present absent document in the administrative offer 48 hours after opening
- ✓ There's any fake document, False declaration or forged document
- ✓ Omission or change of quantified unit
- ✓ The enterprise hasn't been suspended by MINMAP
- ✓ There's absence of quantified unit price

#### 15.2: MAIN QUALIFICATION CRITERIA:
