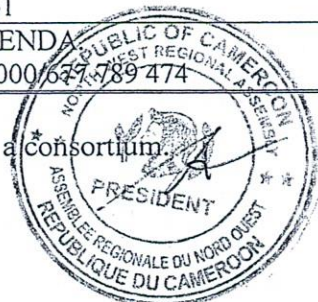

1. The Government of Cameroon has received funding from the World Bank to finance the cost of the Local Governance and Resilient Communities Project (PROLOG). As part of its implementation, PROLOG has signed an agreement with the Northwest Regional Assembly Council to build community and inter-communal infrastructure. To this end, the Northwest Regional Assembly intends to use part of the sums granted under this agreement to make the payments provided for under the contract relating to **Construction of North Western Mutan Market in Bamenda III, North West Region**
2. The execution period for the works is **Four (04) months**. A description of the qualification criteria to be met by tenderers is given in section III (Evaluation and qualification criteria).¹

NB: For this contract, no margin of national preference is applicable.
3. Bidding will be conducted through national competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" of *february 2025* ("Procurement Regulations") and is open to all Bidders as defined in the Procurement Regulations.
