1. BACKGROUND AND JUSTIFICATION
The Government of Cameroon has received funding from the World Bank to finance the cost of the Local Governance and Resilient Communities Project (PROLOG). As part of its implementation, PROLOG has signed an agreement with the Southwest Regional Assembly Council to build

community and inter-communal infrastructure. To this end, the Southwest Regional Assembly
