1. Subject of the invitation to tender:

Within the framework of the 2025 Budget of the Presidential Plan for the Reconstruction and Development of the NW/SW Regions (PPRD), the Senior Divisional Officer hereby launches an Open National Invitation to Tender by Emergency Procedure FOR THE CONSTRUCTION OF A BRIDGE (8 ml) AT SAMPSON GEORGE STREET, BEHIND THE MAMFE MAIN MARKET, LINKING EGBEKAW VILLAGE.

#### 2. Nature of work:

The works comprise the outcome of the preliminary studies carried out and the detailed information provided for in the technical specifications.

#### 3. Execution deadline

The maximum deadline provided for by the Project Owner for the execution of the works forming the subject of this invitation to tender is FOUR (04) months.

## 4. Estimated cost

The estimated cost after preliminary studies is 91 071 432 FCFA.

5. Participation and origin

Participation is open to duly legalized Cameroonian enterprises that fulfil the requirements of this invitation to tender.

6. Funding

Services, subject of this invitation to tender shall be funded by the Presidential Plan for Reconstruction and Development For North West and South West Regions (PPRD) for the 2025 financial year as follows:

7. Bid bond

Each bidder must include in his administrative documents, a bid bond issued by a first-rate banking establishment approved by the Ministry in charge of finance and whose list is found in document N°

10 of the Tender File, of an amount of 1, 821 500 FCFA and valid for thirty (30) days beyond the date of validity of bids. As per article 90 (9) of the public contract code (Decree No 2018/366 of 20 June 2018) dertified cheques or bank cheque are acceptable in the place of bid bond.

## 8. Consultation of tender file:

#### 11. Admissibility of bids

Under pain of being rejected, only originals or certified true copies from the issuing service administrative authorities (Senior Divisional Officers, Divisional Officers, etc.) of the documents required must imperatively be produced in accordance with the Special Conditions of the Invitation to tender. They must not bolder than three (03) months.

Any bid not in conformity with the prescriptions of this notice and tender file shall be declare inadmissible. Especially the absence of a bid bond issued by an approved bank by the Ministry in charge c Finance or the non-respect of the models of the Tender File documents shall lead to outright rejection of the bi-without appeal.

12. Opening of bids:

The bids shall be opened in a single (01) phase on 24/07/2025. at 10 am local time by the Divisional Tenders Board in the Conference Hall of MINEPAT Manyu by the Divisional Tenders' Board. Only bidders may attend or their duly accredited representatives with Power of Attorney.

#### 13. Evaluation criteria

It has any fake or forged document;

Absence of quantified unit price.

It carries any false information.

Omission or change of qualified unit

Must have been suspended by MINMAP

Deadline for delivery higher than prescribed;

Non-respect of 75% of essential criteria;

External envelope carrying a sign that a identify bidder;

## ii.. Main Qualification criteria

The criteria for qualification of candidates should be on the following:

Access to credit or other financial sources (60 million francs at least): Yes/No General presentation of the tender file: yes/No Safety and security measures on the site; Yes/No Logistics: Yes/No Attention and report of site visit; Yes/No Special technical clauses initialled in all the pages; yes/No Special Administrative clauses completed and initialled in all the pages; Yes/No References of similar jobs: Yes / No Availability of material and essential equipment Yes/No Yes/No Experience of supervisory staff: Yes/No Methodology Yes/No Certificate of non-abandonment of project within Manyu. Non-respect of two (02) of the above criteria shall entail rejection of the bid.
