The Government of Cameroon has received financing from the OPEC Fund toward the cost of the Rice Value Chain Development Project (RVCDP) and intends to apply part of the proceeds for consultant services.

The consulting services ("the Services") include:

#### Design and Supervision Consultant (DSC)

The service of a Design and Supervision Consultant is procured with the following major objectives:

- To provide engineering expert service/advise in pre-construction, construction, and post-construction phase of the project.
- To ensure the suitability/accuracy of designs, quality construction and transparent project management and execution.
- To mitigate/resolve probable technical problems/deadlocks associated with the project and hence accelerate project execution.
- To ensure technically sound project implementation and contract administration.
- To ensure proper project close-out.

The Supervision Consultant shall be required to provide necessary service/support to the implementing agency in engineering and contract management aspects of the project, so that above mentioned objectives shall be achieved.

#### **Project Implementation Schedule**

The total duration of the consulting services will be 33 months followed by a 12 months defects liability period. The consultant is expected to be on board five months before the start of procurement of civil works contracts to review all the detailed designs. All civil works contracts are expected to be completed within 32 months' duration. It is assumed that the total involvement of the consultant / duration of the contract will be 45 months.

The Government of Cameroon has received financing in the amount of USD 25 million equivalent from the OPEC fund for International Development (hereafter Fund) toward the cost of the **Rice Value Chain Development Project**, and it intends to apply part of the proceeds to payments for goods, works, non-consulting services and consulting services to be procured under this project. This project will be parallel co-financed by the ISDB, BADEA, KUWAIT and Cameroon Government and OPEC Fund will cover the North-West region.

The project has six (6) components and OPEC Fund will cover Component 1, 2 and part of Component 5, which is Project Management Cost.

**Component 1** will focus on construction of production/postharvest infrastructure and equipment as well as inputs for increasing rice production and productivity. Activities would include developing 5000ha of paddy field and its irrigation network, acquiring modern farm and post-harvest equipment, and acquiring seeds and complementary technologies through a partnership with the Institute of Agronomic Research for Development (IRAD).

**Component 2** aims to enhance the profitability of smallholder farmers and small/medium-scale rice processors by improving their access to markets and capacity to add value to locally produced paddy and processed rice. Activities includes: constructions of rice processing units, setting up of market places and Market Information System, rehabilitation/construction of rural access roads and construction of warehouses.
