DECISION BEARING ON THE AWARD OF THE CONTRACT FOLLOWING THE PUBLICATION OF RESTRICTED NATIONAL INVITATION TO TENDER N° 250/RNIT/PULCCA/MIDENO/MITB/13/84/2025 OF 13TH MAY 2025 WITHIN THE FRAMEWORK OF THE WORLD BANK PROJECT TO COMBAT FOOD CRISIS IN CAMEROON (PULCCA) THROUGH MUTUAL AGREEMENT PROCEDURE FOR THE ACQUISITION AND DISTRIBUTION OF IMPROVED SOLANUM POTATO SEEDS FOR FARMERS IN MEZAM DIVISION.

HEREBY DECIDES AS FOLLOWS

Article 1: GOLDEN MINDS & Co. LIMITED COMPANY, has been awarded the contract FOR THE ACQUISITION AND DISTRIBUTION OF IMPROVED SOLANUM POTATO SEEDS FOR FARMERS IN MEZAM DIVISION, for the sum of ONE HUNDRED AND NINETY ONE MILLION FOUR HUNDRED THOUSAND (191,400,000) FCFA VAT inclusive.

Article 2: THE ACQUISITION AND DISTRIBUTION OF THE IMPROVED SOLANUM POTATO SEEDS shall be delivered within the duration of TWO (02) Months from the date of notification to start the assignment.
