DECISION BEARING ON THE AWARD OF THE CONTRACT FOLLOWING THE PUBLICATION OF RESTRICTED NATIONAL INVITATION TO TENDER N° 264/RNIT/PULCCA/MIDENO/MITB/13/84/2025 OF 13TH MAY 2025 WITHIN THE FRAMEWORK OF THE WORLD BANK PROJECT TO COMBAT FOOD CRISIS IN CAMEROON (PULCCA) THROUGH MUTUAL AGREEMENT PROCEDURE FOR THE ACQUISITION AND DISTRIBUTION OF IMPROVED SOLANUM POTATO SEEDS FOR FARMERS IN MENCHUM DIVISION.

HEREBY DECIDES AS FOLLOWS

Article 1: ALPHA OMEGA HOLDINGS, has been awarded the contract **FOR THE ACQUISITION AND DISTRIBUTION OF IMPROVED SOLANUM POTATO SEEDS FOR FARMERS IN MENCHUM DIVISION**, for the sum of **ONE HUNDRED AND SIX MILLION TWO HUNDRED THOUSAND (106,200,000) FCFA VAT inclusive**.

Article 2: THE ACQUISITION AND DISTRIBUTION OF THE IMPROVED SOLANUM POTATO SEEDS shall be delivered within the duration of TW (02) Months from the date of notification to start the assignment.
