HEREBY DECIDES AS FOLLOWS

Article 1. That KING'S COMPANY LIMITED, MILE 4 NKWEN BAMENDA is awarded Request for Quotation No 001/RFQ/BIIIC/BIIICITB/MINDDEVEL/PROLOG/NWR/2025 OF 30/09/2025 FOR THE CONSTRUCTION OF A WATER CATCHMENT (TANK AND SUPPLY TO COMMUNITIES INCLUSIVE) AT NTAMBANG IN BAMENDA III SUBDIVISION, MEZAM DIVISION OF THE NORTH WEST REGION, worth 20,499,000 (Twenty Million Four Hundred and Ninety Nine Thousand) CFA francs inclusive of taxes.
