1. Subject of the invitation to tender

As part of the implementation of the Public Investment Budget, the Mayor of Massangam council, project owner launches on behalf of the Ministry of Water and Energy, a Call for closed National Offers in emergency procedure for the construction work of three (03) boreholes equipped with human-powered pumps respectively in the localities of MANGUEDOUM, MANKOUNKOU CHIEFDOM, KOUTOULANDEN, Massangam Council, Noun Division, West Region.

2. Nature of works

The work, objects of this Call of Offers, concern the construction work of three (03) boreholes equipped with human-powered pumps respectively in the localities of MANGUEDOUM, MANKOUNKOU CHIEFDOM, KOUTOULANDEN, Massangam Council, Noun Division, West Region.

The consistency of these works is detailed in the "Detailed estimate" and in the "Unit Price List" of each lot.

3. Execution deadline

The maximum turnaround time provided by the contractor for the work is three (03) months. The period runs from the date of notification of the service order to begin work

4. Allotment

The work is in a single batch.

5. Estimated cost

The estimated cost of the operation following preliminary studies is twenty-seven million (27 000 000) CFA F

6. Participation and origin

7. Financing

Works under this tender shall be financed by the Public Investment Budget of the MINEE as part of the 2026 annual program and following.

8. Provisional bid bond

Each tenderer must attach to his administrative documents a tender security in the form specified in the Bidding Documents and the amount of which is:

9. Consultation of tender file

The tender document may be consulted during working hours at the Massangam Council.

10. Acquisition of tender file

The tender documents may be consulted and obtained at the Massangam Council, section of publics contracts upon presentation of an original of a non-refundable treasury receipt of payment into the Massangam Council Treasury as **54 000 (fifty four thousand) FCfa**

11. Submission of offers

Each offer Drafted in English or French and in seven (07) copies, including one original and six (06) copies, labelled as such, tender shall be submitted in a sealed envelope and against a receipt at the unit of launching of tenders of the Internal Commission in charge of Public Contracts situated at the Massangam Council, not later than **02/02/2026 at 10 o'clock** They shall bear the following:

12. Admissibility of offers.

Under pain of rejection, the administrative documents required, must be produced in originals or true copies certified by the issuing service or an administrative authority (Senior Divisional Officer, Divisional Officer...) in accordance with the Special Conditions of the invitation to tender.

They must not be more than three months preceding the original date of submission of bids (3) months or must not have been established after the signing of the tender notice.

Any incomplete offer in accordance with the prescriptions of this notice and tender file shall be declared inadmissible. Especially the absence of a bid bond issued by a first-rate bank approved by the Ministry in charge of Finance.

13. Opening of bids

The administrative documents, the technical and financial proposals shall be opened on **02/02/2026 at 12 O'clock** local time, At the Internal Commission in charge of Public Contracts situated at the Massangam Council

Tenders shall be opened in one go and in three steps:

Step 1: Opening of envelope A containing the administrative document (volume 1);

Step 2: Opening of envelope B containing the technical proposal (volume 2);

Step 3: Opening of envelope C containing the financial offer (volume 3).

All tenderers may attend the opening session or each has themselves represented by one mandated person of their choice (even in the event of a joint-venture) with sound knowledge of their file

14. Evaluation criteria

Eliminatory criteria

Bids shall be eliminated according to the following criteria:

- Absence of bid bond at the opening of bids;
- Absence of the receipt of the of deposits and consignments fund
- Administrative file (no compliance of an administrative file) not completed in 48 h.
- False declarations, fraudulent schemes or forged documents;
- Appear on the updated list of suspended companies;
- Failure to comply with 70% essential criteria to the qualification threshold of technical bids;
- Absence of the sworn statement for not having abandoned contracts during the last three years;
- Failure to comply with bids file format;
- Absence of a quantified unit price in the financial offer;
- Omission of declaration to submit;
- Insufficient Production of the offer's copies;
- To have presented one civil servant;
- Absence of integrity charter dated and signed
- Absence of the dated and signed commitment statement to comply with environmental and social clauses.

Essential criteria

Bids shall be evaluate according to the following criteria:

- The presentation of the offer (**02 criteria**);
- Supplier's references (**05 criteria**);
- Experience of supervisory staff (**06 criteria**);
- Material and essential equipment (**05 criteria**);
- The execution methodology, the planning, the site's visit report and proposals of execution (**05 criteria**);
- The financial offer of the candidate (**02 criteria**).

15. Award

The contract will be awarded to the bidder with the least offer who acquires the required technical and administrative capacities.

17. Maximum number of lots:

Single batch

18. Duration of validity of bids

Tenderers shall be bound by their tender for a period of ninety (90) days with effect from the tender-submission deadline.
