



OPEN NATIONAL INVITATION TO TENDER

FOR MAINTENANCE WORK ON FIFTY-TWO (52) STREETLIGHTS EQUIPMENT
IN SOLAR LIGHTING OF CERTAIN SECTIONS IN THE CITY OF DSCHANG

1. SUBJECT OF THE INVITATION TO TENDER

As part of the improvement of the living conditions of the populations of the city of Dschang, the Mayor of Dschang Council launches a consultation for the maintenance work of fifty-two (52) solar lighting streetlights in certain sections in the city of Dschang.

2. CONSISTENCY OF WORKS

The work, subject of this Quotation Request, includes the following operations:

- The necessary technical studies and production of the as-built plan for the repaired streetlights;
- The completion of all civil engineering work (refurbishment of damaged foundations, erosion protection and backfilling, site restoration);
- The supply and installation of complete kits ("All In One" modules);
- Dismantling and recovery of existing components to be returned to the town hall, in particular (crossarms, light fixtures, metal boxes, batteries, regulators, wiring and accessories, and solar panels, including their supporting structure);
- Modification of the existing pole heads to facilitate the fitting of the selected modules (double crossarm and single crossarm);
- Installation of the complete kit (which includes: a battery, lighting, charge and discharge regulator, photovoltaic module, motion and twilight detector, etc.);
- Manufacture and delivery of a metal climbing cage via a YAP truck;
- Supply of a toolbox for maintenance;
- Training of municipal agents responsible for monitoring and maintenance of the teams.

3. EXECUTION TIME

The maximum period specified by the Employer for the execution of the work referred to in this Request for Proposals is **four (04) months** from the date of notification of the service order to start the services.

4. ALLOTMENT

The works are divided into a single lot.

5. FINANCEMENT

The service which is the subject of this Consultation is financed by the **MINDDEVEL** Public Investment budget, Financial Year 2026, for a forecast project cost of **twenty million (20,000,000) CFA Francs** all taxes included.

6. PARTICIPATION

Participation to this consultation is opened to Cameroonians companies specialized in the field concerned and having sufficient legal, financial and technical capacities.

7. PROVISIONAL SURETY

Under penalty of rejection, each tenderer must attach to his administrative documents a bid bond drawn up by a bank of first order or an insurance company approved by the Ministry in charge of Finance and listed in Exhibit 12 of the call for tenders document for an amount equal **one hundred thousand (100,000) CFA francs**, valid for a period of thirty (30) days, beyond the closing date for the validity of the bids.

8. ACQUISITION OF THE CONSULTATION FILE

The file of request for quotation can be obtained at the General Secretary of the Dschang Council, as of the date of publication of this quotation, on presentation of the original of the receipt of payment of a nonrefundable sum of **fifty thousand (50.000) Francs CFA** payable to the Raveling collector of the Council of Dschang.

9. COMPLETION PERIOD

The completion period of the works is fixed at three (03) months as from the date of notification to start the services works.

10. CONSULTATION OF FILE

The file of request for quotation can be consulted during works hours in the General Secretariat of the Dschang council, located on the floor of the principal building of the DSCHANG Council as of the date publication of this quotation.

11. SUBMISSION OF BIDS

Each offer written in English or French an in seven (07) copies whose one (01) original and six (06) copies marked like as, must be deposited to the Secretariat-general of the Dschang council, latest on **March 02, 2026 at 10 a.m.** standard time and have to be marked:

12. TENDER COMPLIANCE

Any other required administrative documents must be produced as original documents or photocopies certified as authentic by the issuing authority within the last three months or in course of validity, according to the listing provided for in the special regulations of the tender, otherwise they shall not be accepted.

Any bid not in compliance with the specifications of this tender notice and file shall be rejected. Notably, the absence of the provisional guarantee issued by a well-established bank approved by the Ministry in charge of Finance or its non-compliance with the model documents of the tender file shall lead to outright rejection of the bid.

13. OPENING OF BID:

Bids shall be opened in one phase. The administrative, technical and financial bids shall be opened on **March 02, 2026 at 11 a.m.** local time by the Council Tenders Board at the Dschang Council.

14. VALIDITY OF OFFERS

Bidders shall be bound by their bids for a period of (90) days with effect from the date of opening of bids.

15. EVALUATION CRITERIA

a. Elimination Criteria

The elimination criteria set out the minimum conditions to be admitted for evaluation according to the essential tanks. Failure to comply with these criteria will result in the tenderer's bid being rejected.

These include:

- Absence of an administrative document not regularized within 48 hours;
- Absence of the bid bond as well as the deposit receipt at the CDEC at the opening of tenders;
- False declaration or falsified document ;
- Omission in the financial offer of a quantified unit price;
- Technical score below 70% (at least 48 "YES" out of 69);
- Lack of financial capacity equal to or greater than ten million (10,000,000) CFA francs;
- Absence of the company's categorization certificate.

b. Essential Criteria

The criteria for the qualification of candidates will be indicative of:

- Financial capacity;
- The references;
- The execution time;
- The staff;
- The materials.

16. RIGHT TO MODIFY QUANTITIES DURING THE AWARDS

The Contracting Authority during the contract awards and before signing the contract by the contractor proposed by the Internal Tender Boards, reserve the right to increase or decrease the amount of certain tasks or services originally specify in the bill of quantities, without any change in unit price or order terms and conditions. The combination of this amendment shall not exceed 20% of the proposed amount include

The Mayor of Dschang Council serves right in case of necessity to add quit other useful subsequent modification to the present invitation to tender.
