

## TENDER NOTICE

### CONSTRUCTION OF SUSPENDED FOOTPATH AT ATINOK

FINANCING: PUBLIC INVESTMENT BUDGET 2026

**1. SUBJECT OF THE INVITATION TO TENDER:**

Within the framework of the Public Investment Budget 2026, the Mayor of Isangele Council, Contracting Authority, hereby launches an Open National Invitation to tender for construction of suspended footpath at Atinok in Isangele Municipality.

**2. NATURE OF WORKS:**

The works comprise the following:

- Earthworks.
- Formwork and concreting.
- Equipment.

**3. EXECUTION DEADLINE**

The maximum execution deadline provided for by the Contracting Authority shall be **Three (03) Months**.

**5. ESTIMATED COST:**

The estimated cost after studies is **fifty million (50 000 000) FCFA** all taxes inclusive for each of the lots.

**6. PARTICIPATION AND ORIGIN:**

Participation is open to duly legalized Cameroonian enterprises or Company that fulfil the requirements of this invitation to tender.

**7. FINANCING**

Works which form the subject of this invitation to tender, shall be financed by Public Investment Budget of the 2026 financial year, budget head

**8. BID BOND:**

Each bidder must include in his/her administrative documents, a bid bond issued by a first-rate banking establishment approved by the Ministry in charge of finance and whose list is found in document No. 11 of the tender file, of an amount of **one million (1,000,000) Francs CFA** valid for **Thirty (30) days** beyond the date of validity of bids

**9. CONSULTATION OF THE TENDER FILE:**

Interested eligible bidders may obtain further information during working hours as from the date of publishing of this tender notice, at the Private Secretariat of the Mayor of the Isangele Council, Tel: **653212239**.

**10. ACQUISITION OF TENDER FILE:**

The complete tender file may be obtained from the office of the Private Secretary to the Mayor of Isangele Council as soon as this notice is published against a payment of a non-refundable sum of **ninety five thousand (95.000) FCFA** payable at the Isangele Council Treasury.

**11. SUBMISSION OF BIDS:**

Each bid drafted in **English or French in seven (07) copies** including **one (01) original** and **six (06) copies** marked as such, should reach the office of the Private Secretary to the Mayor of Isangele Council not later than **24/03/2026 at 9am** and should carry the inscription:

**12. ADMISSIBILITY OF OFFERS:**

Each bidder must include in his/her administrative documents a bid bond issued by a first rate bank approved by the Ministry in charge of finance and recognized by COBAC (Commission Bancaire pour l’Afrique Centrale) featuring on the list in Document 12 of the tender file of an amount of: **one million (1000,000) FCFA** with a validity period of ninety (90) days from the date the bids are opened.

Under penalty of rejection, the required administrative documents must be imperatively produced as original documents or photocopies certified as authentic by the issuing authority, in accordance with the Special Regulations of the Invitation to Tender, within the last three months, otherwise they shall not be accepted.

Any bid not in compliance with the specifications of this tender notice and file shall be declared inadmissible. Notably, the absence of the bid bond issued by a first rate bank approved by the Ministry in charge of finance or its non-compliance with the model documents of the tender file shall lead to outright rejection of the bid without any possibility of appeal.

**13. OPENING OF BIDS:**

The bids shall be opened in a single (01) phase on the **24/03/2026 at 10AM** local time by the Tender Board of the Contracting Authority in Isangele Council Office, in the presence of the bidders or duly authorized representatives having full knowledge of the file (power of attorney).

**14. MAIN EVALUATION CRITERIA:**

Any bid not meeting with the requirements of the Tender File will be declared inadmissible.

**A. ELIMINATORY CRITERIA**

The eliminatory criteria are identified as follows:

- ❖ Absence of a bid bond or false bid bond in the Administrative file;
- ❖ Non-conformity of an administrative file 48h after the deadline prescribed by the regulation;
- ❖ Execution time greater than that prescribed in the Tender that is 3 months
- ❖ False statement or Falsified documents in the Tender Files;
- ❖ Omission in the financial offer of a quantified unit price
- ❖ Presence on MINMAP's list of Enterprises which abandoned the execution of contracts;
- ❖ Technical marks less than 70%
- ❖ Absence of attestation of site visit signed by the Mayor of the Isangele Council

**B. ESSENTIAL CRITERIA:**

The criteria relating to the qualification of candidates could indicatively be the following:

The evaluation of the technical offers will be made according to the binary notation (Yes/No) on the basis of the essential points above in accordance with the RPAO, with a threshold of 70% for all the essential criteria taken into account.

**15. AWARD OF CONTRACT:**

The contract shall be awarded to the bidder with the least financial offer having the technical and administrative files which are in conformity with the tender document/file.

**16. VALIDITY OF OFFERS:**

Bidders shall be bound by their bids for a period of ninety (90) days with effect from the date of opening of bids.
