**1. Subject of the invitation to tender:**

Within the framework of the 2026 PUBLIC INVESTMENT BUDGET, the Mayor Tiko Council hereby launches an Open National Invitation to Tender (BY EMERGENCY PROCEDURE) FOR THE CONSTRUCTION WITH PAVEMENT OF A STRETCH OF ROAD IN MUTENGENE FROM ENTRANCE TO BOBGA STREET BUEA ROAD TO THE ENTRANCE OPPOSITE FORMER PMUC LIMBE ROAD 0.570 KM.

**2. Nature of services**

The works comprise the outcome of the preliminary studies carried out and the detailed information provided in the technical specifications as follows;

**3. Execution deadline**

The maximum deadline provided by the Project Owner or Contracting Authority for the execution of the works forming the subject of this invitation to tender is **three (03) months**.

**5. Estimated cost**

The estimated cost after preliminary studies is **100 000 000 FRS**

**6. Participation and origin**

Participation is open to duly legalized Cameroonian enterprises that fulfill the requirements of this invitation to tender.

**7. Funding**

Services which form the subject of this invitation to tender shall be funded by the PUBLIC INVESTMENT BUDGET of the Ministry of DECENTRALISATION

#### 8. Bid bond

Each bidder must include in his administrative documents, a bid bond issued by a first-rate banking establishment approved by the Ministry in charge of finance and whose list is found in document No. 12 of the Tender File, of an amount of **2,000,000 representing 2% of the project amount]** and valid for thirty (30) days beyond the date of validity of bids

#### 9. Consultation of tender file:

The file may be consulted during working hours from 7:30 am to 3:30 pm at the contracts service of the Tiko council as soon as this notice is published.


#### 10. Acquisition of tender file:

The file may be obtained from the the contracts service of the Tiko council as soon as this notice is published upon presentation of a treasury receipt attesting to the payment of a non-refundable fee of **75.000 FCFA**, payable at the Municipal Treasury Tiko.

#### 11. Submission of bids:

Each bid drafted in English or French in seven (\_07\_) copies including the original and six (06) copies marked as such, should reach the office of the Tiko Council Tenders Board not later than **\_09\_ OF \_04\_ 2026** at 10:00 am and should carry the inscription:

#### 12. Admissibility of bids

Under pain of being rejected, only originals or certified true copies from the issuing service or administrative authorities (Senior Divisional Officers, Divisional Officers, etc.) of the documents required must imperatively be produced in accordance with the special conditions of the Invitation to tender. They must not be older than three (03) months.

Any bid not in conformity with the prescriptions of this notice and tender file shall be declared inadmissible. Especially the absence of a bid bond issued by an approved bank by the Ministry in charge of Finance or the non-respect of the models of the Tender File documents shall lead to outright rejection of the bid without appeal.

#### 13. Opening of bids:

The bids shall be opened in a single (01) phase on the **\_09\_ OF \_04\_ 2026** at 11:00 am local time by the Tiko Council Internal Tenders Board in the Conference Hall of Tiko Council.

Only bidders may attend or be represented by a duly mandated person.

#### 14. Evaluation criteria

##### Evaluation criteria

##### i. Eliminary Criteria

- In case of absence or non-conformity of an administrative document, the bidder will be given 48 hours to produce or replace the document in question.
- (non-conformity of administrative documents, technical offers and specifications)
- antecedents of bad execution of contracts etc. (in conformity with circular letter No. 002/LC/MINMAP/CAB OF 25<sup>TH</sup>

January 2017 relating to the taking into account the failures of companies in the execution of previous contracts in the attribution of new contracts.

- The technical score is less than the minimum required;
- It has any fake or forged document;
- Absence of quantified unit price.
- Noncompliance with the model bid documents (Documents 9 and 10).
- It carries any false information.
- Less than 70% of the qualification criteria

**ii. Main Qualification criteria**

The criteria for qualification of candidates should be on the following:

- ❖ Access to credit or other financial sources (50 million francs at least)  
Yes / No
- ❖ References of similar jobs;  
Yes / No
- ❖ Availability of material and essential equipment Yes / No
- ❖ Experience of supervisory staff  
Yes / No
- ❖ Methodology Yes/No
- ❖ Turnover as in business license above or equal to 50,000,000 million francs CFA;
- ❖ Qualified personnel relevant to the job.

Non-respect of two (02) of the above criteria shall entail rejection of the bid.  
NB: the marking scale for bids by award of points is banned in favor of the binary method (Yes or No).

**15. Award**

The Contract shall be awarded to the contractor fulfilling the **best technical and financial conditions**.

**16. Validity of bids**

Bidders will remain committed to their bids for ninety (90) days from the deadline set for the submission of tenders
