RELATING TO THE CANCELLATION OF OPEN NATIONAL INVITATION TO TENDER (EMERGENCY PROCEDURE) N°12/ONIT/PPRD-NWSW/STB/2026 OF 09/03/2026, FOR THE SUPPLY OF AGRICULTURAL EQUIPMENT, INPUTS TOOLS AND MATERIALS IN THE NORTH WEST REGION.


HEREBY DECIDES AS FOLLOWS:
