1. Subject of the invitation to tender

Within the framework of the improvement of mobility within the Kumba III municipality, most especially its drainage facilities, the Lord Mayor of the Kumba III Council hereby launches an Open National Invitation to Tender for the construction of an 8m bridge over Number Two Water along Appolinaire Street in Kumba III Sub-Division, Meme Division, South West Region.

2. Nature of works

The works comprise notably:

- Installation
- Preliminary and earthworks
- Drainage
- Road sign boards and security equipment
- Painting

3. Execution deadline

The maximum deadline provided by the Project Owner is fixed at **five (05) months**.

4. Lots

The works consist of **one (01)** unique lot.

5. Estimated cost

The estimated cost after preliminary studies is **120 119 250 FCFA**.

6. Participation and origin

Participation in this Invitation to Tenders is open, on equal terms, to all companies and businesses under Cameroonian law with proven experience in the construction sector.

7. Financing

Works of this invitation to tender shall be financed by Public Investment Budget - MINTP of the 2026 financial year; Chapter 36, Paragraph 23411.

8. Bid bond

Each bidder must include in his administrative documents, a bid bond issued by CDEC Yaoundé of an amount of **600,596 F CFA** and valid for **ninety (90) days** beyond the date of validity of bids.

Also, the bid bond must be in compliance with the model of the Tender file.

9. Consultation of tender file

The file may be consulted during working hours at the Kumba III Council as soon as this notice is published.

10. Acquisition of tender file

The file may be obtained at Kumba III Council as soon as this notice is published against payment of the sum of **100 000 (One hundred thousand) CFA francs**, payable at Kumba III Council Municipal Treasury.

11. Submission of bids

Each bid drafted in English or French in seven (7) copies including the original and six (6) copies marked as such, should reach The Kumba III Council not later than the **28/04** at **10 am** and should carry the inscription:

12. Admissibility of bids

Under penalty of being rejected, only originals or true copies certified by the issuing service or administrative authorities (Senior Divisional Officer, Divisional Officers) must imperatively be produced in accordance with the Special Regulations of the invitation to tender.

They must obligatorily be not older than three (3) months preceding the date of submission of bids or may be established after the signature of the tender notice
Any bid not in compliance with the prescriptions of the Tender File shall be declared inadmissible. This refers especially to the absence of a bid bond issued by a first-rate bank approved by the Minister in charge of Finance.

13. Opening of bids

The bids shall be opened in a single phase.

The opening of administrative documents and the technical and financial bids shall be on the **28/04/2026** at **11am** local time by the Kumba III Council Internal Tenders Board situated at the Kumba III Council, and in the presence of all bidders.

Only bidders may attend or be represented by a duly mandated person.

14. Evaluation criteria

- i. Eliminary criteria**
 - a) Absence of the bid bond;**

- c) **False statement, falsified or non-genuine document;**
- d) **Incomplete Technical Offer for absence of:**
- Attestation of site visit and site visit report;
 - The declaration on honour attesting that the tenderer has not abandoned a contract during the last three years, and that he is not on the list of failing companies established by MINMAP;
 - A Works supervisor with the qualification required in the tender documents;
 - The section "organization, methodology and planning"
- e) **Omission of a quantified unit price in the Price Schedule and the Bill of Quantities;**
- f) **Incomplete Financial Offer for absence of any of the following:**
- A submission;
 - The Unit Price Schedule according to the model with indication of the prices excluding VAT in figures and in letters, filled in a legible way;
 - Bill of Quantities;
 - The sub-detail of unit prices;
- g) **Proposal of a civil servant among the supervisory staff;**
- h) **Not having validated the first five (05) essential criteria after the marking of the essential technical criteria.**
- ii. **Essential criteria**
- ◆ Financial capacity;
 - ◆ Enterprise's experience;
 - ◆ Personnel;
 - ◆ Equipment;
 - ◆ Organization, methodology and planning;
 - ◆ General presentation

15. Award

The contract will be awarded to the tenderer submitting the lowest evaluated bid and fulfilling the required administrative, technical and financial criteria.

16. Validity of bids

Bidders will remain committed to their bids for **90 days** from the deadline set for the submission of bids.
