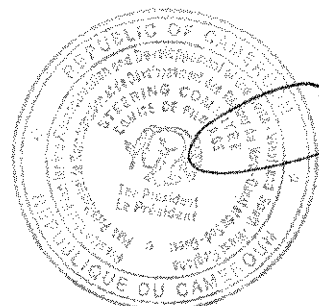
**HEREBY DECIDES AS FOLLOWS:**

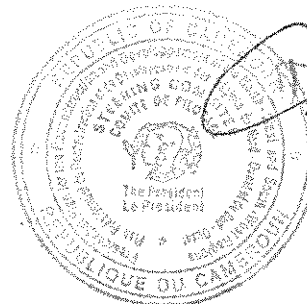
