TO AWARD THE CONTRACT AFTER OPEN NATIONAL INVITATION TO TENDER (EMERGENCY PROCEDURE) N°08/ONIT/PPRD/STB/2026 OF 02/03/2026 FOR THE REHABILITATION AND UPGRADING OF ELECTRICITY TO THREE PHASE FROM KUMBO TO MBIAME, (FROM DZENG VILLAGE TO RIFEM HOSPITAL), MBVEN SUB DIVISION, BUI DIVISION, NORTH WEST REGION (PHASE 2).
