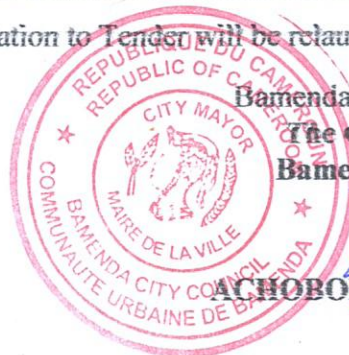
#### **HEREBY DECIDES AS FOLLOWS:**
