Article 1: ETS L & E, has been awarded the Jobbing Order FOR THE ACQUISITION AND DELIVERY OF 1,500 BAGS OF ORGANIC FERTILIZER TO SUPPORT COFFEE FARMERS, for the sum of THIRTY MILLION (30,000,000) FCFA VAT inclusive.
