- Considering the Open National Invitation to Tender N°001/ONIT/BCC/ITB/2026 of 20th February 2026 for the tarring with double coat surface dressing of some roads in Bamenda I Sub Division.

HEREBY DECIDES AS FOLLOWS:

Article 1: That **SAMSYTECH COMPANY CAMEROON P.O. Box 5007 Bamenda, Tel:672 249 771**, is awarded the **CONTRACT N°001/C/BCC/SG/DTS/SIGAMP/2026** for the tarring with double coat surface dressing of some roads in Bamenda I Sub Division worth two hundred and forty-four million three hundred and twelve thousand two hundred and ninety-five (244,312,295) CFA francs inclusive of all taxes.

Article 2: That **SAMSYTECH COMPANY CAMEROON** will execute the works in **three (3)** calendar months as from the date of notification of the service order to start the services.

Article 3: That the drafting and the formatting of the documents constituting this Contract are ensured by the Contracting Authority and the reproduction of the present Contract in seven (07) subscribed copies is equally the responsibility of the Contracting Authority.
