HEREBY DECIDES AS FOLLOWS:

Article 1: That TRANSIT Enterprise Ltd, P.O. Box 549 Bamenda, Tel: 677 74 46 64, is awarded **Jobbing Order N°001/JO/BCC223/SG/DTS/SIGAMP/2026** for the rehabilitation of streets lights along some major streets in Bamenda worth **fifteen million five hundred and two thousand five hundred (15,502,500) Francs CFA** inclusive of all taxes.

Article 2: That TRANSIT Enterprise Ltd will execute the works in **two (02) calendar months** as from the date of notification of the Service Order to start work.

Article 3: That the drafting and the formatting of the documents constituting this contract shall be done by the Contracting Authority and the reproduction of the present contract, in eight (8) subscribed copies is at the charges of the contractor.
