Considering Letter N°073/2026/L/STB-PPRD NW-SW of 29 April 2026 from the President of the Special Tenders Board.

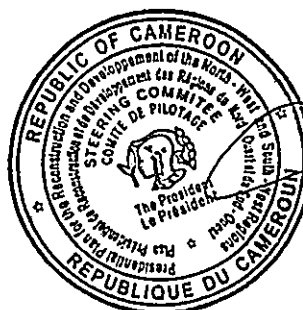
HEREBY DECIDES AS FOLLOWS:
