N/B This is a rebidding exercise and bidders are allowed to bid for single items as appropriate. Bids will be evaluated for individual items taking into account all unconditional discounts including discounts for combination of items, if any. Contract or Contracts will be awarded to the Bidder or Bidders offering the lowest evaluated cost to the Purchaser for all items combined.

3. Bidding will be conducted through the International Competitive Bidding (ICB) procedures as specified in Fund's Principles for Procurement of Goods, works

and Services (*the Principles*) and Procedures for procurement of goods, works and non-consulting services (*the Procedures*), and is open to all eligible bidders.
