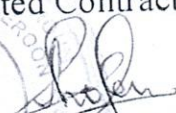

HEREBY DECIDES AS FOLLOWS:

Article 1: That **FORBAN & SONS COMPANY Ltd**, P.O. Box 535 Bamenda, Tel: 677 23 28 01, is awarded the **Contract N°006/C/BCC223/SG/DTS/SIGAMP/2026** for the extension of electricity with three-phase transformer at Ntahfor quarter in Nkwen Bamenda III Sub Division worth **eighty-two million four hundred and fifty-eight thousand (82,458,000) Francs CFA** inclusive of all taxes.
