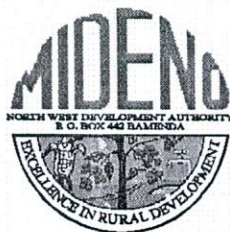

DECISION BEARING ON THE CREATION OF A TECHNICAL COMMISSION TO CARRY OUT THE TECHNICAL AND PROVISIONAL ACCEPTANCE OF JOBBING ORDER N° 002/MIDENO/B/MITB/13/84 OF 17th JUNE 2026 FOR THE ACQUISITION AND DELIVERY OF 560 TINS OF CARROT SEEDS TO SUPPORT COFFEE FARMERS (LOT 1)

- Mindful of Decree N° 2004/75 of 24/9/2004 instituting the Public Contracts Code;
- Mindful of Decree N° 2018/366 of 20th June 2018 revising the Public Contracts Code
- Considering Jobbing Order N° 002/MIDENO/B/MITB/13/84 of 17th June 2026 for the acquisition and delivery of 560 tins of carrot seeds to support coffee farmers (Lot 1)
- Considering correspondence No 028/2/ from **TIMM Co. Ltd (The Contractor)** dated **27th July 2026** to the Project Owner requesting for the technical and provisional acceptance of the Jobbing Order;
