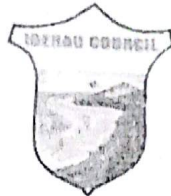

1. Subject of the invitation to tender:

Within the framework of the 2026 Public Investment Budget, the Mayor of Idenau Council hereby launches an Open National Invitation to Tender by **Emergency Procedure** **FOR THE REHABILITATION OF A STRETCH OF ROAD WITH PAVEMENT BLOCKS FROM THE NR3 PASSING THROUGH THE IDENAU BANQUET HALL TO THE LOW COST HOUSES** *(Length: 210 m; Width: 8 m and 11 m).*

2. Nature of work:

The works comprise the outcome of the preliminary studies carried out and the detailed information provided for in the technical specifications.

3. Execution deadline

The maximum deadline provided for by the Project Owner for the execution of the works forming the subject of this invitation to tender is **three (03) months**.

4. Estimated cost

The estimated cost after preliminary studies is **50 000 000 FCFA**.

5. Participation and origin

Participation is open to duly legalized Cameroonian enterprises that fulfil the requirements of this invitation to tender.

6. Funding

Services, subject of this invitation to tender shall be funded by the Public Investment Budget of the 2026 financial year as follows: **BUDGETARY HEAD:**

7. Bid bond

Each bidder must include in his administrative documents, a bid bond issued by a first-rate banking establishment approved by the Ministry in charge of finance and whose list is found in document N° 12 of the Tender File, of an amount of 1 000 000 F CFA and valid for thirty (30) days beyond the date of validity of bids.

If the bidder is awarded the contract/jobbing order, the bid bond will be released after the final bond has been established.

The bid bond should be provided in accordance with the Circular Letter N° 000019/LC/MINMAP of 5th June 2024 relating to the modalities of constitution, deposit, conservation, restitution and withdrawal of bond on public contracts. This bid bond should be authenticated by a certificate issued by CDEC.

8. Consultation of tender file:

The file may be consulted during working hours (7:30 am – 3:30 pm) at the **General Secretariat, Idenau Council** as soon as this notice is published.

9. Acquisition of tender file:

The file may be obtained from the office of the **General Secretariat, Idenau Council** as soon as this notice is published against payment of a non-refundable sum of 50 000 FCFA for the tender to the Idenau Municipal Treasury with an acknowledgement receipt thereof.

10. Submission of bids:

Each bid drafted in English or French in *seven (07) copies* including the original and six (06) copies marked as such, should reach the **General Secretariat, Idenau Council** on ~~15/09/26~~ *12/08/2026* at 10.00 am local time and labelled.

- Envelope A : Administrative bid;
- Envelope B : Technical bid ;
- Envelope C : Financial bid.

NB: These three (03) envelopes shall be put in the fourth envelope and shall be the only one to have the label mentioned below

Any document poorly drawn-up, not bound as per Article 24 of the Public Contracts Code or not produced in Seven (7) copies shall be rejected.

11. Admissibility of bids

Under pain of being rejected, only originals or certified true copies from the issuing service or administrative authorities (Senior Divisional Officers, Divisional Officers, etc.) of the documents required must imperatively be produced in accordance with the Special Conditions of the Invitation to tender. They must not be older than three (03) months.

Any bid not in conformity with the prescriptions of this notice and tender file shall be declared inadmissible. Especially the absence of a bid bond issued by an approved bank by the Ministry in charge of Finance or the non-respect of the models of the Tender File documents shall lead to outright rejection of the bid without appeal.

12. Opening of bids:

The bids shall be opened in a single (01) phase on 18/07/21 at 11.00 am local time by the Idenau Council Internal Tenders Board in the **Conference Hall**, located at Idenau Council premises. Only bidders may attend or their duly accredited representatives with Power of Attorney.

13. Evaluation criteria

i. Main Eliminator Criteria

- A bid shall be rejected if:
- It lacks a bid bond in the Administrative document in accordance with the rules and regulations in force;
 - The technical score is less than the minimum required;
 - It has any fake or forged document;
 - Absence of quantified unit price.
 - It carries any false information.
 - Enterprise has any abandoned project

ii. Main Qualification criteria

The criteria for qualification of candidates should be on the following: Yes / No

- ❖ Access to credit or other financial sources (25 million francs at least): Yes / No
- ❖ References of similar jobs: Yes / No
- ❖ Availability of material and essential equipment : Yes / No
- ❖ Experience of supervisory staff: Yes / No
- ❖ Methodology Yes/No
- ❖ Turnover as in business license above or equal to 50 million francs CFA; Yes/No

Non-respect of two (02) of the above criteria shall entail rejection of the bid.

NB: the marking scale for bids by award of points is banned in favour of the binary method (Yes or No).

14. Award

The Contract shall be awarded to the contractor fulfilling the **best technical and financial conditions**.

15. Validity of bids

Bidders will remain committed to their bids for ninety (90) days from the deadline set for the submission of tenders

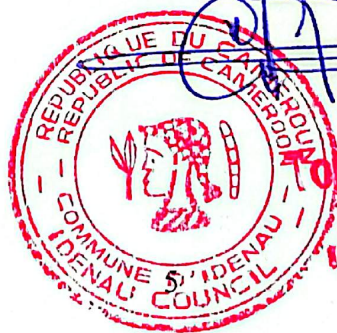
